LAND ALLOTMENT ORDER.

As approved by the Govt. Of A.P. vide approval order No.LR-48/94 of Dated Itanagar, the 21st June' 2019, an area measuring = 10271 Sqmtrs / 2.537 Acres located near Govt. Higher Secondary School, Daporijo is hereby allotted to the Kendra Vidyalaya Sangathan, Upper Subansiri District for establishment of Kendra Vidyalaya School and staff Quarter at Daporijo town subject to payment of Annual Lease Rent @ Rs. 1/-per Acre per annum for 99 years or as fixed by the Govt. from time to time.

The following terms & conditions laid down for the allotment of land to be followed;

1. The allotment is subject to all the relevant rules and regulation of the land allotment, under the (Arunachal Pradesh Land Settlement and Records) Act, 2000 under Chapter III, of Section 12.
2. The allottee will have to construct permanent structure within one year from the date of allotment
3. The allottee will restrict the construction and occupation within the allotted area as identified and earmarked by the SK and Mandal. No construction either temporary or permanent structure is allowed beyond the allotment area rather it shall be demolished by the authority and further action will be taken under relevant provision of law.
4. The allottee is strictly prohibited to transfer or sell the land allotted to any other department without prior approval of the government, any attempts to do so can result to cancellation of the land allotment order.
5. The allottees will have to abide by the regulations and orders of the authorities issued from time to time.
6. Any violation on the part of allottee will lead to cancellation of the allotment and the plot shall be re-allotted to other deserving department if allottee fails to construct and deposit the land revenue as and when ask for by the authorities.
7. The allottee should erect permanent fencing within the allotted land and protect it from public encroachment.
